



## Installation


Strip away 25-30 mm ( $\sim$ 1 in.) of the cable jacket and separate the wires into 4 pairs. Cut the wire holder flush with the cable jacket.






## Installation

2 IDC Color Codes for T568A/B wiring installations:



Using the T568A and T568B IDC color codes on the rear panel, connect each respective wire to its corresponding patch panel pin with a punch-down tool.





3 Place the cables in the holders to keep them neatly organized, then position the patch panel as desired.
