Installation

1 Insert the HDMI cable firmly into the cable tie base. The base should be pushed up as close to the connector as possible.



2 Remove the locking screw adjacent to the device's HDMI port. Secure the cable tie to the device with the same locking screw.



Note: If the device does not contain a locking screw, please use the screw included with the cable lock.

3 Connect the HDMI cable to the device.



4. Insert the cable tie into the cable tie base, firmly pulling on it and removing any slack so the HDMI connector does not come unplugged.
