- Supports DisplayPort Alternate Mode (DP 1.4) for connecting a 4K HDMI monitor to the device's HDMI port, while transferring data via the USB-C port at speeds up to 5 Gbps.
- Supports 4K x 2K Ultra High Definition (UHD) video resolutions up to 3840 x 2160 @ 60 Hz, with 4:4:4 color and HDR.

Note: 4K/60 Hz resolution is only attainable when used with a host that supports DP 1.4 Alternate Mode. When connected to a DP 1.2 Alt Mode host, the max resolution drops to 4K/30 Hz due to decreased bandwidth.

- USB-A and USB-C hub ports support data transfer rates up to 5 Gbps and are backward compatible with previous generations.
- The USB Type-C port supports both data transfer and Power Delivery (PD 3.0) charging with power input up to 20V 5A (100W).
- Plug-and-play; no software or drivers required.

Installation

 Connect the adapter's USB-C port to the USB-C port on your laptop, tablet or other compatible device.

Note: For optimal performance, a DisplayPort (DP) 1.4 Alt Mode enabled device is required.

- Connect the adapter's HDMI port to the HDMI port on a monitor using an HDMI cable (such as Tripp Lite's P568-Series High-Speed HDMI Cables).
- **3.** Connect a USB Type-C enabled device to the adapter's USB-C port using a Type-C cable (such as Tripp Lite's U420-Series USB Type-C Device Cables).

OR

- **4.** Charge your device by connecting its USB-C Charger to the adapter's USB-C port.
- **5.** Connect a USB device to the adapter's USB-A hub port.
